Founded in 1979, the Legal Services Center (LSC) is a community-based non-profit/public interest law firm and one of Harvard Law School's clinical training sites for law students. Each year, LSC lawyers and students provide free legal help to more than a thousand people from Greater Boston with legal issues such as:

- · Debt Collection and Bankruptcy
- Unfair Loans or Contracts
- · MA Criminal Record (CORI) Sealing
- Domestic Violence Orders, Divorces, Custody and Visitation Orders
- DCF Fair Hearing appeals to challenge supported allegations of abuse or neglect
- LGBTQ+ Advocacy and Litigation
- Eviction Defense
- · Housing Discrimination
- Federal and State Tax Problems
- Veterans Federal and State Benefits
- Military Discharge Upgrades and Records Corrections
- Estate Planning for Veterans
- Social Security Disability Benefits (SSDI/SSI) for Adults
- Food Stamps/SNAP

In addition to helping people one-on-one, we use many other strategies to fight for justice, such as class action lawsuits, policy advocacy, reports, and partnering with community groups, healthcare programs, and others.

### Our Practice Groups and the Types of Cases We Handle

### Consumer Protection Clinic 617-384-0744

We help consumers dealing with debt collection, including being sued on credit card debt, dealing with unfair collection efforts, or facing loss of wages. We also help individuals fight consumer scams.

### Criminal Record (CORI) Sealing 617-390-2524

We help people move on from encounters with law enforcement systems as juveniles and/or adults by sealing their Massachusetts criminal records.

### Family Justice Clinic 617-522-3003

We help survivors of domestic violence with divorce, custody and parenting, abuse prevention orders, paternity, child support, and guardianship cases. The Family Justice Clinic also helps parents during DCF investigations and challenge DCF's support determinations in administrative Fair Hearings. Unlike the other practice groups, our clients are referred to us from hospitals, health centers, and other community partners.

### LGBTQ+ Advocacy Clinic 617-522-3003

We help members of the LGBTQ+ community with legal issues arising out of their LGBTQ+ status, with a particular focus on issues affecting underrepresented groups within the LGBTQ+ community.





### Housing Clinic 617-384-0760

We help Boston tenants facing eviction from their homes. We defend against evictions and file lawsuits for clients seeking to improve housing conditions; help tenants seal eviction records; fight housing discrimination; make sure tenants aren't being treated unfairly by their landlords; and prevent homelessness.

### Housing Justice for Survivors 617-384-0752

We help survivors of domestic violence, sexual assault, stalking, and sexual harassment who need to move to safe housing or who are trying to keep their homes. We represent clients facing eviction, loss of housing subsidies, those in need of safety transfers, and people who need to terminate their tenancies for safety reasons.

### Tax Litigation Clinic 617-384-0750

We help taxpayers in disputes with the Internal Revenue Service/IRS and/or the Mass. Department of Revenue/DOR. Typical cases include tax debt/collection, Tax Court, disallowed dependents or earned income tax credit, identity theft, injured and innocent spouse claims, audits and reconsiderations.

We help veterans and their family members in the following areas:

We help eligible veterans and their families in appeals at all levels (agency and court) for federal VA veterans benefits, Massachusetts Chapter 115 veterans benefits, and in military discharge upgrade and records correction cases.

We help local veterans and their spouses or dependent children by drafting estate planning documents such as wills, health care proxies, powers of attorney, medical directives, and special needs trusts.
